- 3. To engage in the promotion, marketing, and sale of various products and services, including but not limited to consumer goods, insurance, electronic devices, and other items, as a Direct Selling Agent (DSA) on behalf of manufacturers, suppliers, and service providers. To enter into agreements, partnerships, or collaborations with third parties for the purpose of marketing and selling their products and services as a DSA. To comply with all relevant laws and regulations governing the direct selling industry and to adhere to the guidelines issued by regulatory authorities.
- 4. To provide income-generating opportunities and wealth creation mechanisms to the members of the company through direct selling activities and network marketing. To establish a compensation plan, incentives, and bonuses for members based on their sales performance and the growth of their downlines. To provide training, support, and resources to members to enhance their skills and abilities in the field of direct selling.
- 5. To carry on the business of

buying, selling, reselling, importing, exporting, transporting, storing, promoting, marketing or supplying, dealing in any manner whatsoever in all type of goods on retail as well as on wholesale basis in India or elsewhere. To carry on the business as exhibitors of various goods, services and merchandise and to undertake the necessary activities to promote sales of goods and services through direct selling agents or firm and services.

- 6. To purchase, exchange or otherwise any movable or immovable property and any rights or privileges which the Company may deem necessary or convenient for the purpose of its main business.
- 7. To enter into partnership or into any arrangement for sharing profits, union of interest, joint venture, reciprocal concession or co-operation with persons or companies carrying on or engaged in the main business or transaction of this Company.
- 8. To import, buy, exchange, alter, improve and manipulate in all kinds of plants, machinery, apparatus, tools and things necessary or convenient for carrying on the main business of the Company.
- 9. To vest any movable or immovable property, rights or interests required by or received or belonging to the Company in any person or company on behalf of or for the benefit of the Company and with or without any declared trust in favour of the Company.
- 10. To purchase, build, carry out, equip, maintain, alter, improve, develop, manage, work, control and superintend any plants, warehouse, sheds, offices, shops, stores, buildings, machinery, apparatus, labour lines, and houses, warehouses, and such other works and conveniences necessary for carrying on the main business of the Company.

- 11. To undertake or promote scientific research relating to the main business or class of business of the Company.
- 12. To takeover the whole or any part of the business, goodwill, trade-marks properties and liabilities of any person or persons, firm, companies or undertakings either existing or new, engaged in or carrying on or proposing to carry on business this Company is authorised to carry on, possession of any property or rights suitable for the purpose of the Company and to pay for the same either in cash or in shares or partly in cash and partly in shares or otherwise.
